Secretary Report

Minutes for the October 16, 2018 special meeting was approved upon unanimous vote after motion by Gary Hicks, and second by Gary Norris

Old Business

CSX railroad update

No new information. Gary Hicks will follow-up with a contact he obtained from Anthony Habermehl.

WWTP site Tree Removal update

Of all the bids received, Rhett Kelsch is the lowest bid. The funds will not be available until Frbruary 15. We have until March 15th to remove the tree. Motion by Tom

Courtner to have Rhett Kelsch remove the tree for \$500. Second by Gary Hicks. Passed by unanimous vote.

Bore vs Dig in Augusta update \$140,000 for open cut \$277,000 for directional bore.

We agreed that if we did directional bore then that would save money and time because of the archeological requirements. Directional bore would require an archeologist at the five start and stop points. The State Historical Preservation Office has given the verbal okay to perform directional bore and we expect to receive a formal response soon.

Flood Plain Permit update

This was completed and notarized and sent to HMB.

Audit

We have a proposal from RFH to perform the 2018 audit not to exceed \$5600. Motion to continue the audit with RFH not to exceed \$5600 by Gary Norris. Second by Tom Courtner. Passed by unanimous vote.

Nursing Home screen update

We are going to have them do a screen which will cost about \$3,000-\$4,000 and have them take care of the maintenance of it.

Jeannie Briley asked about what would happen if more bones are found. Kristie Dodge explained about halting construction and contacting a coroner. Archeologist will determine what happens next. Tribes will be consulted. Ms. Briley also asked if this

cost has been budgeted with contingencies. Randal and Kristie explained that part of the budget.
